INFORMATION WE COLLECT:

However, we also collect additional information when delivering our Services to you to ensure necessary and optimal performance. These methods of collection may not be as obvious, so we wanted to explain what these might be and how they work.

Account related information is collected in association with your use of our Services, information requests and notes or details on our interactions.

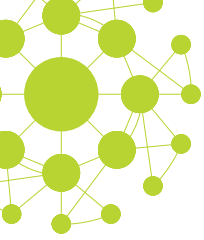
HOW WE USE INFORMATION:

We strongly believe in both reducing the amount of data we collect and limited the use and purpose of that data to only:

1. Data for which we need to support your service
2. Data necessary to deliver the services you have purchased
3. Data we might be required or permitted to keep for legal compliance or other lawful purposes.

These uses include:

- Improve and optimise the operation and performance of our Services
- Diagnose problems with and identify any security risks or errors.



SHARING WITH TRUSTED THIRD PARTIES:

We may share your personal data with a trusted third-party service providers as necessary for them to perform services on our behalf, such as:

- Preparing quotes and Tenders
- Contractors
- Quantity Surveyors

We only share your personal data as necessary for any third party to provide the service as requested or as needed on our behalf. These third parties are subject to strict data processing terms and conditions and are prohibited from utilising sharing or retaining your personal data for any purpose other than as they have been specifically contracted for.

HOW WE SECURE, STORE, AND RETAIN YOUR DATA:

We follow generally accepted standards to store and protect the personal data we collect, both during transmission and once received and stored, including utilisation of encryption where appropriate. We retain personal data only for as long as necessary to provide the Service you have requested and thereafter for a variety of legitimate legal or business purposes.

These might include retention periods:

- Mandated by law, contract, or similar obligations applicable to our business operations;
- for preserving, resolving, defending, or enforcing our legal / contractual rights; or
- needed to maintain adequate and accurate business and financial records.

HOW YOU CAN ACCESS, UPDATE OR DELETE YOUR DATA
